The Embassy of the United States of America invites you to submit a quotation for fire alarm and sprinkler system inspection services at the U.S. Government premises located in Ottawa. If you are interested in submitting a quotation for this service, read the instructions included in the attached Request for Quotation (RFQ).

The Embassy intends to conduct a site visit and hold a pre-proposal conference. The conference will be held at 490 Sussex Drive, Ottawa, on February 11, 2021 at 10:00 a.m. EST. All prospective offerors who have received a solicitation package are invited to attend and must confirm their attendance by providing names to [ContractsOttawa@state.gov](mailto:ContractsOttawa@state.gov) prior to February 9, 2021.

Site conditions allow for maintaining social distancing of 6.5 feet to prevent transmission of COVID-19, however, the number of attendees shall be limited to 1 person per company and up to 3-4 visitors in total. All attendees are required to use their own respiratory masks. An additional site visit may be scheduled to ensure that social distancing is maintained. No hard copies of documents will be distributed during the meeting.

In order for a proposal to be considered, you must also complete all relevant sections of RFQ requiring Offeror's input and submit all sections of the RFQ.

The contract will be a firm fixed price contract, with no adjustment for any escalation in costs or prices of labor or materials. Each offeror will be responsible for determining the amount of labor and materials that will be required to complete the project, and for pricing its proposal accordingly.

Please be advised that each offeror is responsible for furnishing complete information to its subcontractor and suppliers, such as details and quantities required by the drawings and specifications. Subcontractors and suppliers should not be referred to the Embassy for determining the amount or quantities of materials required.

The Contracting Officer reserves the right to reject any and all proposals and to waive any informality in proposals received. In addition, the Embassy reserves the right to establish a competitive range of one or more offerors and to conduct further negotiations concerning price and other terms before awarding the contract, or to award without discussions.

1. SCOPE OF CONTRACT

The Contractor shall provide Fire Alarm and Sprinkler System Inspection Services for U.S. Embassy Ottawa located at 490 Sussex Drive, Ottawa.

The performance period of this contract is from the start date in the Notice to Proceed and continuing for 12 months, with four (4) one-year options to renew.

2. PRICING

This is a firm-fixed price contract for the base period with four (4) one-year options.

- (a) The Contractor shall provide the services for the base period of the contract at the rates shown below and any option years exercised by the Government.
- (b) The prices listed below shall include all labor, materials, overhead and profit.
- (c) All prices are in Canadian dollars.

2.1 VALUE ADDED TAX

1. INTRODUCTION

- 1.1 The United States Department of State (DOS) requires services to perform maintenance on the fire pump and fire sprinkler system as required by NFPA 25 standard for U.S. Embassy Ottawa.
- 1.2 Service work to the fire pump and sprinkler system must be completed in accordance with the following:

NFPA 25; Inspection, Testing, and Maintenance of Water-Based Fire Protection Systems  
NFPA 13; Installation of Sprinkler Systems  
NFPA 72; National Fire Alarm Code  
NFPA 20; Installation of Stationary Pumps for Fire Protection  
NFPA 14; Installation Standpipe Systems

1.3 The Chancery, located at 490 Sussex Drive, Ottawa is protected by an existing fire sprinkler system with a fire pump. The sprinkler system includes an “Aurora-Wilson” 1000 gpm pump and TornaTech controller. The Fire Alarm is controlled by a Siemens MXL panel.

2. PERFORMANCE WORK STATEMENT

The Contractor shall provide the following inspections/tests for U.S. Embassy Ottawa life/property protection systems:

- (1) Annual Fire Alarm System Inspection per ULC S536 M04
- (11) Monthly Fire Alarm System Inspections and Tests per ULC S536 M04
- (1) Annual Sprinkler System Inspection
- (5) Bi-Monthly Sprinkler Inspections with Fire Alarm System Bypassing
- (1) Annual Fire Pump Test

NO REPAIRS ARE TO BE PERFORMED UNDER THIS CONTRACT. Service calls and parts replacement for repairs for batteries, wiring problems (i.e. ground faults), Acts of Nature, vandalism, or any ancillary equipment are not included in this contract.

3. GENERAL REQUIREMENTS

3.1 Post’s Contracting Officer’s Representative (COR). Individual who is designated and authorized in writing by the Contracting Officer to perform specific contract administration or technical functions on contracts.

3.2 Project Manager: The Contractor shall assign a specific project manager who will be the direct liaison with the COR concerning all work related to this contract. It will be the project manager’s task to direct, schedule, supervise, inspect and test the work under this contract, and to receive instructions from the COR.

Quality control shall be the responsibility of the Contractor. The Contractor shall perform inspection

visits to the work site on a regular basis. These visits shall be coordinated with the COR.

3.3 Fire Pump Certified Representative: Contractor personnel conducting fire pump work and/or testing shall be qualified and fire pump certified by the pump manufacturer.

3.4 Fire Alarm Technicians: Contractor personnel conducting fire alarm system work and/or testing shall be a registered CFAA Fire Alarm Technician qualified and experienced in accordance with ULC S536 M04.

The Fire Alarm technician shall be capable of executing all software programming and adjustments required to complete this SOW.

The Fire Alarm technician shall have all tools, both software and hardware, factory support, required to effect repairs to this specific Fire Alarm system and its components, to include special software programs, licenses, administrative passwords and tools required to access and update instructions to control panels, annunciating devices, sensors and all other components. Microprocessor based systems are often upgraded, via its software or firmware microchips to maximize operational system capability, introduce new features, address technical issues and/or meet up-to-date code requirements. Contractor manufactured parts and components found defective as a result of normal wear and tear will be replaced without charge.

3.5 Acceptance of Work. The services will be inspected from time to time by the COR, or his/her authorized representatives, to determine that all work is being performed in a satisfactory manner. The Contractor shall be responsible for any countermeasures or corrective action, within the scope of this contract, which may be required by the Contracting Officer as a result of such inspection.

#### 4. DELIVERABLES

Following each visit, the contractor must provide completed Inspection, Testing and Maintenance form(s) to the COR. Recommended repairs and or replacement of equipment shall be commented on the completed inspection forms – NO REPAIRS ARE TO BE PERFORMED UNDER THIS CONTRACT.

Contractor to submit completed inspection CAN-ULC (with fire pump curve) within 5 days following the annual inspections and tests to the designated COR.

#### 5. INSPECTION BY GOVERNMENT

The services will be inspected from time to time by the COR, or his/her authorized representatives, to determine that all work is being performed in a satisfactory manner.

The Contractor shall be responsible for any countermeasures or corrective action, within the scope of this contract, which may be required by the Contracting Officer as a result of such inspection.

#### 6. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan is designed to provide an effective surveillance method to promote effective Contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the

Government is to conduct quality assurance to ensure that contract standards are achieved.

#### 6.1.1 SURVEILLANCE

The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

#### 6.1.2 STANDARD

The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.246-4, Inspection of Services – Fixed Price (AUG 1996)), if any of the services exceed the standard.

#### 6.1.3 PROCEDURES

(a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

(b) The COR will complete appropriate documentation to record the complaint.

(c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

## 7. SECURITY

For the Government to conduct all necessary security checks, the Contractor shall provide the list of

personnel and supervisor assigned to this project.

### Personnel Security

After receipt of the Notice of Award, the Contractor has ten (10) calendar days to submit to the Contracting Officer the following requirements for the Government to conduct all necessary security checks: (1) list of workers and supervisors assigned to this project, and (2) completed Authority for Release Information of each personnel. The Contractor shall use the form provided under Section 1, Attachment 1.

The Contractor personnel shall obtain a security clearance by successfully passing a background check to the satisfaction of the U.S. Embassy Ottawa. The U.S. Government reserves the right to disqualify a contractor personnel who is unable to obtain and maintain satisfactory clearance.

## 8. STANDARDS OF CONDUCT

(a) General. The Contractor shall maintain satisfactory standards of employee competency, conduct, cleanliness, appearance and integrity and shall be responsible for taking such disciplinary action with respect to employees as required. Each Contractor employee is expected to adhere to standards of conduct that reflect credit on themselves, their employer, and the United States Government. The Government reserves the right to direct the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional cost to the Government.

(b) Uniforms. The Contractor's employees shall wear clean, neat and identifiable uniforms, although not necessarily identical uniforms. All employees shall wear accreditation at all times.

(c) Disorderly conduct, use of abusive or offensive language, quarreling, intimidation by words, actions, or fighting shall not be condoned. Also included is participation in disruptive activities that interfere with normal and efficient Government operations.

(d) Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances that produce similar effects.

(e) Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These include but are not limited to the following actions:

- Falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records or concealment of material facts by willful omission from official documents or records;
- Unauthorized use of Government property, theft, vandalism, or immoral conduct;
- Unethical or improper use of official authority or credentials;
- Security violations; or,
- Organizing or participating in gambling in any form.

(f) Key Control. The Contractor shall receive, secure, issue and account for any keys issued for access to buildings, offices, equipment, gates, etc., for the purposes of this contract. The Contractor shall not duplicate keys without the COR's approval. Where it is determined that the Contractor or its agents have duplicated a key without permission of the COR, the Contractor shall remove the individual(s) responsible from this contract. If the Contractor has lost any such keys, the Contractor shall immediately

notify the COR. In either event, the Contractor shall reimburse the Government for the cost of rekeying that portion of the system.

(g) Neglect of duties shall not be condoned. This includes sleeping while on duty, unreasonable delays or failures to carry out assigned tasks, conducting personnel affairs during duty hours and refusing to render assistance or cooperate in upholding the integrity of the work site security.

## 9. PERSONNEL HEALTH REQUIREMENTS

All employees shall be in good general health without physical disabilities that would interfere with acceptable performance of their duties. All employees shall be free from communicable diseases.

## 10. LAWFUL OPERATION, PERMITS, AND INDEMNIFICATION

(a) Bonds. The Government imposes no bonding requirement on this contract. The Contractor shall provide any official bonds required, pay any fees or costs involved or related to the authorization for the equipping of any employees engaged in providing services specified under this contract if such bonds or payments are legally required by the local government or local practice.

(b) Employee Salary Benefits. The Contractor shall be responsible for payment of all employee wages and benefits required by host country law or agreements with its employees. The Government, its agencies, agents, and employees shall not be part of any legal action or obligation regarding these benefits which may subsequently arise. Where local law requires bonuses, specific minimum wage levels, and premium pay for holidays, payments for social security, pensions, sick or health benefits, severance payments, child care or any other benefit, the Contractor is responsible for payments of these costs and must include them in the fixed prices in this contract.

(c) Personal Injury, Property Loss or Damage (Liability). The Contractor assumes absolute responsibility and liability for any and all personal injuries or death and property damage or losses suffered due to negligence of the Contractor's personnel in the performance of this contract. The Contractor's assumption of absolute liability is independent of any insurance policies.

(d) Amount of Insurance. The Contractor is required to provide whatever insurance is legally necessary. The Contractor shall, at its own expense, provide and maintain during the entire performance period the following insurance amounts:

General Liability (includes premises/operations, collapse hazard, products, completed operations, contractual, independent contractors, broad form property damage, personal injury)

The types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.

For those Contractor employees assigned to this contract who are either United States citizens or direct hire in the United States or its possessions, the Contractor shall provide workers' compensation insurance in accordance with FAR 52.228-3.

The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to:

- (a) Any property of the Contractor,
- (b) Its officers,
- (c) Agents,
- (d) Servants,
- (e) Employees, or
- (f) Any other person, arising from and incident to the Contractor's performance of this contract.

The Contractor shall hold harmless and indemnify the Government from any and all claims arising, except in the instance of gross negligence on the part of the Government.

The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

The Contractor shall obtain these permits, licenses, and appointments in compliance with applicable host country laws. The Contractor shall provide evidence of possession or status of application for such permits, licenses, and appointments to the Contracting Officer with its proposal. Application, justification, fees, and certifications for any licenses required by the host government are entirely the responsibility of the Contractor.

## 10. CERTIFICATE OF INSURANCE

When coverage is provided by self-insurer, the Contractor shall not change or decrease the coverage without the Contracting Officer's approval.

- (c)(1) If the Contractor is a foreign person and has only a partial or no exemption to the withholding, the Contractor shall include the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, with each voucher or invoice submitted under this contract throughout the period in which this status is applicable. The excise tax withholding is applied at the payment level, not at the contract level. (B) *The taxpayer is delinquent in making payment.* A taxpayer is delinquent if the taxpayer has failed to pay the tax liability when full payment was due and required. A taxpayer is not delinquent in cases where enforced collection action is precluded.

(ii) *Examples.*

(A) The taxpayer has received a statutory notice of deficiency, under I.R.C. §6212, which entitles the taxpayer to seek Tax Court review of a proposed tax deficiency. - (4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and
- (5) Any trust if—
  - (i) A court within the United States is able to exercise primary supervision over the administration of the trust; and
  - (ii) One or more United States persons have the authority to control all substantial decisions

of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at [www.irs.gov/w14](http://www.irs.gov/w14). Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS.
