1.0 PERFORMANCE WORK STATEMENT

1.1 The Contractor shall provide specialized customized solutions to U.S. Foreign Commercial Service (USFCS) including event promotion, lead generation and recruitment (registration) of Canadian business to join the U.S. Embassy's official delegation to the SelectUSA 2016 Investment Summit to be held on June 19-21, 2016 and in accordance with the Description/Specification/Work Statement described under this contract.

1.2 The contractor shall provide the following information required under the contract as follows: (a) demonstrated experience in investment attraction and/or investor lead generation, (b) outline a recruitment plan for the project, and (c) firm-fixed price based on recruitment of 10, 20, 30, and 40 firms.

1.3 This is a fixed price type contract. The fixed price will include all work, including furnishing all labor, materials, equipment, services, and all associated costs such as overhead (including cost of Workers' Compensation and War-Hazard Insurance, which shall not be a direct reimbursement), profit, administration, project management, supervision and VAT unless otherwise specified.

1.4 All prices will be in Canadian Dollars.

1.5 The contract will be from the date indicated in the notice of award through May 30, 2016.

2.0 PRICING

2.1 In consideration of satisfactory performance, the contractor shall be paid a fixed-price at the rates shown below. No additional sums will be payable on account of any escalation in the cost of materials, equipment or labor or because of the contractor's failure to properly estimate or accurately predict the cost or difficulty of achieving the results required by this contract. Nor will the contract price be adjusted on account of fluctuations in the currency exchange rate.

2.2 VALUE ADDED TAX

The Contractor shall include VAT or applicable tax as a separate charge on the Invoice and as a separate line item in Section 2.0.

1.0 Information About U.S. and Foreign Commercial Service

The U.S. and Foreign Commercial Service (US&FCS), under the presidential mandate of the [SelectUSA](#) program, requires specialized solutions for the purpose of promotion, leads generation and recruitment activities of approximately 40 Canadian firms throughout the Canadian business community, local associations, regional economic development offices (EDOs), and Canadian government agencies, to join the U.S. Embassy-led Canadian delegation to attend the [SelectUSA 2016 Investment Summit](#). Estimated number of companies for the recruitment efforts shall be from 10-40 firms.

2.0 Information About the SelectUSA Summit

The SelectUSA 2016 Investment Summit is the premier U.S. investment promotion event to take place at the Hilton Hotel in Washington, DC on June 19-21, 2016. The event will feature 2,100 participants, attendance from economic development organizations (EDOs) from every U.S. state, and investors from over 70 countries. The event website is: www.selectusasummit.us. The SelectUSA Canada website is: www.selectusa.gov/canada.

3.0 Recruitment Company Profile

US&FCS of the U.S. Embassy in Ottawa has been tasked with recruiting a delegation of 80 Canadian businesses across industry and service sectors to attend the SelectUSA 2016 Investment Summit as part of the Embassy's delegation. While manufacturing companies are prioritized, service companies, and innovative, fast-growing start-ups should also be considered. Prospects may represent SMEs or large corporations, but should possess the following characteristics:

- (a) Already engaged in international business/trade activities,
- (b) Able to financially support a presence in the United States,
- (c) Strong interests in establishing a presence in the United States through either new investment or expansion of existing operations, and
- (d) An executive responsible for expansion activities.

4.0 Contractor Requirements

4.1 The contractor must provide evidence of past experience handling projects involving prospective investor lead generation and/or recruitment of companies to attend high visibility business or investment events.

4. Contractor's experience can include a plethora of manufacturing, technology and service industries.

The contractor's goal is to recruit companies to attend the SelectUSA Investment Summit, outline Foreign Direct Investment (FDI) opportunities available to the Canadian business community, and explain the economic benefits of establishing operations in the United States.

5.0 Specific contractual solutions shall include, but are not limited to:

- ✓ Recruit up to 40 delegates to join the Canadian delegation to the [SelectUSA 2016 Investment Summit](#) through a combination of developing marketing and promotional strategies to support recruitment efforts.
- ✓ Use USFCS promotional materials (electronic brochures, flyers, booklets, ads, etc.) to support promotion efforts
- ✓ Create a targeted list of Canadian firms and provide a final list to USFCS Toronto office for consideration prior to recruitment
- ✓ Establish strong contacts and develop leads
- ✓ Pre-qualify potential prospect firms by verifying that potential investors are headquartered in Canada and that these are not service providers
- ✓ Educate prospective leads on the registration process
- ✓ Provide weekly recruitment updates to a designated point of contact at USFCS Toronto office based on a spreadsheet to be provided.
- ✓ Participate in conference calls, as needed to discuss recruitment prospects and updates.

6.0 QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP).

6.1 This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

6.2 Surveillance. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

6.3 Standard. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

6.4. Procedures

6.4.1 If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

6.4.2 The COR will complete appropriate documentation to record the complaint.

6.4.3 If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

6.4.4 If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

6.4.5 The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

6.4.6 If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

6.4.7 The COR will consider complaints as resolved unless notified otherwise by the complainant.

6.4.8 Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

SECTION 4 - EVALUATION FACTORS

Award will be made to the lowest priced, acceptable, responsible quoter. The quoter shall submit a completed solicitation, including Sections 1 and 5.

The Government will perform an initial review of proposals/quotations received to determine compliance with the terms of the solicitation. The Government may reject as unacceptable proposals/quotations which do not conform to the solicitation.

Technical Acceptability. Technical acceptability will include a review of past performance and experience as defined in Section 3, along with any technical information provided by the offeror with its proposal/quotation.

The Government reserves the right to reject proposals that are unreasonably low or high in price.

The lowest price will be determined by multiplying the offered prices times the estimated quantities in “Prices - Continuation of SF-1449, block 23”, and arriving at a grand total, including all options, if any.

The Government will determine quoter acceptability will be determined by assessing the quoter's compliance with the terms of the RFQ.

The Government will determine quoter responsibility by analyzing whether the apparent successful quoter complies with the requirements of FAR 9.1, including:

- Adequate financial resources or the ability to obtain them;
- Ability to comply with the required performance period, taking into consideration all existing commercial and governmental business commitments;
- Satisfactory record of integrity and business ethics;
- Necessary organization, experience, and skills or the ability to obtain them;
- Necessary equipment and facilities or the ability to obtain them; and
- Otherwise qualified and eligible to receive an award under applicable laws and regulations.

SECTION 5 OFFEROR REPRESENTATIONS AND CERTIFICATIONS

“Manufactured end product” means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;
- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
